1. Call to Order

6. Presentation of 2020 Audited Financial Statements and Treasurer's Report for 2020

Ms. Maria Rosalina T. Coyiuto, Senior Vice-President for Corporate Support and Chief Finance Officer, presented the 2020 Audited Financial Statements and Treasurer's Report for 2020.

Ms. Anita Victoria M. Ramos asked Ms. Coyiuto to expound on the Company's growth in investment income despite the challenges brought about by the COVID-19 pandemic. Ms. Coyiuto explained that as for investments, the company had a total investment portfolio of P1.38B which is 8.18% higher from the previous year. This resulted to an investment income of 43.97M or 8.46% higher than that of the previous year. Mostly we have placed our investments on short term time deposits as well as in treasury notes with periods for at least 5 years that are high yielding. This good investment result is primarily because of the efforts of our investment team who made sure such investments are placed in the best available investment in the market.

The Chairman asked if there were any other matters for further discussion. Hearing none, the Chairman thereafter declared the Treasurer's Report for 2020 as noted.

A copy of the Treasurer's Report for 2020 is hereto attached (Annex III) and is made an integral part hereof.

7. Approval for Release of the Audited Financial Statements for 2020

Mr. Francisco M. Bayot, Jr., Lead Independent Director and Chairman of the Audit Committee, presented for consideration and approval of the stockholders the Audited Financial Statements as at December 31, 2020 (with comparative figures for December 31, 2019), as audited by Sycip Gorres Velayo & Co, and as signed by Juan Carlo B. Maminta, Engagement Partner.
