

MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS

Held at the Board Room, 5th Floor, Coyiuto House, 119 C. Palanca Street, Legaspi Village, Makati City on August 29, 2019 at 10:30 A.M.

1. Call to Order

Mr. Robert Coyiuto, Jr. Chairman of PGA Sompo Insurance Corporation (the "Corporation), called the Meeting to order and presided over the same. The Chairman, thereafter, requested the Ms. Corazon T. Tulio, to record the Minutes of the Meeting, in the absence of the Corporate Secretary, Ms. Guia Magdalena Laguio-Flaminiano.

2. Certification of Quorum


The designated Secretary certified that since majority of the elected directors are present in this Meeting, there existed a quorum for the valid transaction of business.

3. Approval of the Minutes of Last Month's Board Meeting

The Members of the Board of Directors of the Corporation was requested to review the Minutes of the Board Meeting for the previous month, held on August 1, 2019.

Mr. James G. Coyiuto moved to dispense with the oral reading of last month's Minutes and the same be approved as presented in this Meeting, which was seconded by Atty. Celestino L. Ang.

Hearing no objections to the motion duly made and seconded, the Minutes of the Board Meeting for the previous month, held on August 1, 2019, was unanimously approved.
